# **DUMPSTER RENTAL AGREEMENT**

This Roll-Off Dumpster Rental Agreement ("Agreement") is entered into by and between SMALL SOLUTIONS LLC DBA SMALL DUMPS ("Company") and the client ("Client"), collectively referred to as the "Parties," for the rental of a roll-off dumpster ("Dumpster") as specified below:

- 1. Dumpster Rental Details:
  - a. Dumpster Size: Size will be specified in the quote/invoice.
  - b. Rental Period: Rental period will be specified in the quote/invoice.
  - c. Rental Price: Price will be specified in the quote/invoice.

## 2. Rental Purpose:

The Dumpster is rented to the Client for the sole purpose of disposing of waste materials generated during [Specify the purpose of the rental, e.g., construction, renovation, clean-up, etc.].

- 3. Rental Restrictions:

## 8. Governing Law and Jurisdiction:

This Agreement shall be governed by and construed in accordance with the laws of the State of Florida. Any disputes arising out of or in connection with this Agreement shall be subject to the exclusive jurisdiction of the state and federal courts located in BAY COUNTY.
